Proposed Protocol for Background Checks on Gulf Council Advisory Panel Applicants

The Gulf Council will solicit applicants for various advisory panels in June of each year.

Applicants complete an online application for Council consideration. By typing in their name and entering a date the applicant affirms that the information provided is accurate. A checkbox, when checked, grants permission to NOAA Office of Law Enforcement and State Marine Law Enforcement Agencies to conduct a fisheries violation background check.

Once the Council makes appointments to its panels, the completed applications will be submitted to the appropriate State Marine Law Enforcement Agency and NOAA Office for Law Enforcement to conduct fisheries violation background checks.

State Marine Law Enforcement Agencies will provide the information back to the Gulf Council within ten working days.




