## Agenda Item IV: Draft of 5-year EFH Review

### Timeline Status: Draft

### **Committee Input and Next Steps:**

Staff will present the outline and overview of the EFH document. The Committee is requested to review the document and provide staff with any comments or edits that it would like incorporated into the final document. Staff will present the final document to the Committee at the October Council meeting. The EFH 5 year review is due by December 2016.

Agenda Item V: Summary of the Joint Shrimp AP/Coral SSC/AP Meeting

### **Committee Input and Next Steps:**

Staff will present the summary from the meeting that was held at the Council Office on August 3-4 of the Coral SSC, the Coral AP and the Shrimp AP. The letter will need to be submitted by Friday, August 19<sup>th</sup>, 2016.
